2. Were there any changes suggested to the List A of the TMC? From the survey, the FDRG concluded that minor changes were warranted for descriptors HOSP 110, 120, 130, 140, and 150. All were listed in List A. There were no recommendations for removal or replacement of courses in List A.

FDRG recommends

HOSP 110- Sanitation and Safety- Modification: Change "Completion of Food Handler Exam, Quizzes, Assignments, and Participation" to state, "*May include Food Service Sanitation Management Exam, Completion of Food Handler Exam, Quizzes, Assignments, Participation*".

HOSP 120- Hospitality Cost Control- Modification: Remove Financial Accounting (C-ID ACCT 110) from a Prerequisite to an *Advisory*.

HOSP 130- Introduction to Food and Beverage Management; Modification: Change Header in document from "Descriptor C-DI HOSP 130" to "*Descriptor C-ID HOSP 130*". Change Rationale from "Universally Required Course" to "*N/A*".

HOSP 140- Introduction to Hotel Management- Modification: Change "Determine room rates based on different strategies such as the Hubbart Formula" to "*Determine room rates based on different strategies*".

HOSP 150- Hospitality Law; Modification: Change Header in document from "Descriptor C-DI HOSP 150" to "*Descriptor C-ID HOSP 150*".

3. Were there any changes suggested to the List B section of the TMC? The FDRG concluded from the survey, that no changes in courses or modification of courses were needed in List B.

FDRG recommends: No changes.

4. If appropriate, were there any changes suggested to the List C section of the TMC?

5. Please provide any general recommendations from the feedback received from the vetting.

The recommendations from the survey and the FDRG are noted above. The FDRG also recommended a minor change to HOSP 100, Introduction to Hospitality, which is the only required CORE course for the TMC. The FDRG recommended a removal of “financial performances” from the descriptor for HOSP 100. The revised description would read,

General Course Description:

Structural overview of the hospitality industry; food and lodging, resorts, tourism enterprises, attractions, and related operations. Focus on orientation to customer service, cultural/economic trends, and career opportunities.

There was also a repeated comment in the survey regarding the awareness of diversity, which prompted the FDRG to work on a diversity statement. We concluded that one is necessary and did complete the statement. However, there is still debate on whether it should be included the course descriptor, content, or objectives area. This remains an ongoing discussion.

The revised HOSP 100 is attached.

FDRG recommends: See above.
